Section 1, Assertion 3 has been incorrectly completed, the authority has not complied with financial regulations in respect of authorisation and approval of payments. This is consistent with the Internal Auditor's response to Internal Control Objective B.

Section 1, Assertion 5 has been incorrectly completed, a risk assessment was not reviewed during the year. This is consistent with the Internal Auditor's response to Internal Control Objective C.

Information has come to our attention from the internal auditor highlighting the fact that Notice of conclusion of audit and external auditor report and certificate were not published on the authority's website by the dates specified in the Accounts and Audit Regulations 2015.
